UPON hearing the counsel the Court made the following O R D E R

The Court is convened through Video Conferencing.

This petition is directed against order dated 07.11.2020 passed by the High Court of Madhya Pradesh at Jabalpur in MCRC No.39271 of 2020 whereby the High Court dismissed the 2<sup>nd</sup> bail application of the petitioner herein.

Heard learned counsel for the petitioner as also the learned Dy.Advocate General appearing on behalf of the respondent-State.

Learned Dy. Advocate General appearing on behalf of the respondent – State vehemently opposed the prayer for granting bail to the petitioner herein on the ground that as he belongs to the State of Jharkhand and there is a possibility of his absconding and not appearing before the trial court.

Having heard learned counsel for the parties and taking into consideration the fact that the petitioner is in custody for the last approximately two years and one month and the alleged amount of cheating is Rs.20,000/-, we are inclined to grant him bail.

The petitioner is, accordingly, directed to be enlarged on bail subject to the condition that he shall not leave the State of Madhya Pradesh. The trial Court may impose any other condition as it may deem fit.

The special leave petition stands disposed of accordingly.
